### Terms and Conditions

Billing credit requests must be submitted no later than **30 DAYS** from date of purchase.

- Applicant must be a BWP customer with an active account.
- The application must be signed, dated, and contain **ALL** of the supporting documentation.
- BWP is not responsible for items lost/destroyed in the mail.
- Credit applies to Pool Covers, Solar Pool Rings and pool cover reels. Pool Cover must conform to the size and shape of the pool and cover at least 85% of the pool's surface to act as an effective barrier to evaporation.
- Credit applies to **NEW** pool covers/reels only.
- Liquid pool covers **DO NOT** qualify.
- BWP reserves the right to conduct a site visit to confirm pool cover compliance.
- The Pool Cover Credit is only available during Stages III-VI of the Sustainable Water Use Ordinance.
- Customers may reapply for a pool cover credit every 3 years, provided that Stage III or above is in effect.
- The billing credit is limited to one bill credit per address up to \$100.00 (\$50 for either credit or \$100 for both)
- The billing credit will be applied within 6-8 weeks of BWP receiving the application.
