The BUSS Program provides an ongoing 12% discount for electric service to income-qualified residents.

Step 1: Review Billing Assistance Amounts and Eligibility Requirements

- Applicants must meet the following conditions to qualify for the program:**
- 1** You are the **account holder** or the **co-applicant** on the BWP account.
 - 2** You meet the **income requirements** for the **Burbank PASS program**, shown on the table on the right. For details please visit: Burbankca.gov/BurbankPASS
 - 3** You provide **documentation verifying household income and size** (see step 4 of this application), for all home/unit occupants over the age of 18.
 - 4** You are **NOT a Lifeline customer**. Lifeline participants are not eligible to participate in the BUSS program.
