Burbank Water and Power is offering rebates for the electrification of residential buildings. Electrification refers to the process of replacing everything that burns fossil fuels with efficient electric alternatives. Residential customers may receive rebates to reduce the costs of purchasing and installing qualifying building electrification (BE) equipment and electric panel upgrades when replacing natural gas appliances.

- **Space heating and cooling:** Central heat pump HVAC, mini-split heat pump
- **Water heating:** Heat pump water heater
- **Laundry:** Heat pump clothes dryer
- **Cooking:** Electric range with induction cooktop, electric range with electric cooktop, electric resistance wall oven

REBATES

The following maximum rebate amounts are available. If you need to upgrade your electric panel to serve the new BE equipment, you may also qualify for an added incentive to offset some of the related costs. The purchase price of the equipment cannot exceed the rebate amount.

STEPS TO INSTALL BE EQUIPMENT AND APPLY FOR A REBATE:

1. Hire a licensed electrician to plan the installation and evaluate if you need a panel/circuit upgrade.
2. If your residence needs a panel upgrade, contact BWP's Service Planning at (818) 238-3575 to determine if the BWP infrastructure serving your residence has enough capacity, or if an upgrade is also needed.
3. Purchase the BE equipment. Be sure that the BE equipment meets all requirements to qualify for a rebate. Please review the program's standard terms and our FAQs at burbankwaterandpower.com/electrify#faq.
4. Take before and after photos of the device(s) and nameplates, including make and model. A photo of the capped gas line is also required.
5. Have your licensed contractor install the BE equipment (in replacement of natural gas appliances) and any panel/circuit upgrades needed. Make sure your contractor obtains all required permits and that your installation passes inspection from Burbank's Building & Safety Division.
6. Apply for a rebate by filling out the application and including copies of the required documentation. Download the application at burbankwaterandpower.com/electrify.

REQUIRED DOCUMENTS CHECKLIST

 - “Before” photo of each fossil-fuel appliance replaced by a BE equipment.
 - “After” photo of each new BE equipment.
- Device nameplate for each BE equipment, including serial number, model number, manufacture date, and certification mark from a nationally recognized testing lab (NRTL), such as Underwriters Labs (UL) or Intertek/Electrical Testing Laboratories (ETL), or the Air-Conditioning, Heating, and Refrigeration Institute (AHRI).
- W-9, completed and signed by party requesting payment (available at irs.gov/pub/irs-pdf/fw9.pdf).
- Copy of all “finaled” permits (issued after passing installation inspection). If you apply for a Panel Upgrade Incentive, please also include your “finaled” panel upgrade permit.
