

Options for Recipients of an Administrative Citation for Violations of the Burbank Sustainable Water Use Ordinance

The intent of the Sustainable Water Use Ordinance is to protect our drinking water supplies. Correction of the water waste violation is the first and most important step.

Additionally, your options are to:

1. CORRECT THE VIOLATION AND PAY THE FINE

Correcting the water waste violation is the first step. If you do not correct the violation, you may receive additional fines. Fines are \$100 for the first violation, \$200 for the second violation, and \$500 for every violation thereafter. To pay the fine, please follow the directions on the citation.

2. CORRECT THE VIOLATION, PAY THE FINE, AND ATTEND A WORKSHOP TO RECEIVE FINE REIMBURSEMENT

Recipients of an initial citation (\$100 fine) may attend a BWP sponsored water conservation workshop and receive reimbursement of the fine.

- Correct the water waste violation
- Pay the fine as instructed on the citation
- Enroll in a BWP sponsored water conservation workshop. Please make sure to note that you are attending the workshop as part of receiving fine reimbursement.

- The BWP account holder must be the person attending the workshop. Make sure to show identification and sign the roster the day of the workshop.
- A check refund of the fine will be mailed within 6-8 weeks after the workshop.

3. CORRECT THE VIOLATION, PAY THE FINE, AND REQUEST AN APPEAL HEARING

The Burbank Municipal Code allows the recipient of an Administrative Citation to contest whether a violation occurred.

- Correct the water waste violation
- Pay the fine as instructed on the citation
- Complete the City of Burbank Request for Appeal Hearing For an Administrative Citation.
 Mail or deliver the completed form along with the fine amount to:
