Rebate requests must be submitted no later than **FOUR MONTHS** from date of purchase.

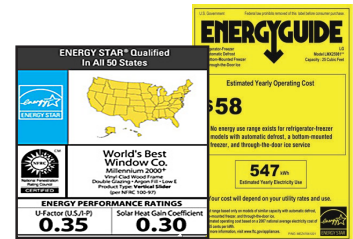
- Applicant must be a BWP customer with an active BWP electrical account.
