3. Description and pictures of equipment removed and replacement equipment installed.
4. Letter of Authorization (if applicable) releasing payment to a third party.
5. Total project costs (parts and labor) with invoices.
6. Completed W-9 form for the entity receiving the rebate.
7. New equipment specifications from the manufacturer.
